	<p>3. 20th Anniversary Celebration: September 7-26th PAC will be featured in the display case in front of the Library. Discussion Re: what celebrations/events to plan. Proposed emphasis on activities in September, with secondary events throughout the year. Kathleen Leatham indicated interest in hosting a Meet the Artist Dinner for Maggie Pike close to September. A contest to obtain art for a card celebrating the arts in F.G, was proposed. Decided to make detailed plans and a schedule of events at our annual retreat this winter. Bring ideas then. Noted that the Library Foundation will be celebrating its 25th Anniversary in 2026.</p> <p>4. Downtown Art Installation(s) FY26-27 TLT Funds - Clock and Rotating Gallery Subcommittee approved by Council. Preliminary discussions focused on an alternative to four 'monument' sculptures in favor of creating a trail of 'hidden gems' that 'tell a story' about Forest Grove to maximize public interest and interaction. The possibilities are wide-ranging, but featuring small local wildlife sculptures attached to things such as benches, light poles and water fountains along with emblems imbedded in the sidewalk generated considerable enthusiasm. An informal meeting with the City Manager and Councilor Gustafson will be scheduled to preview the concept before further planning takes place.</p> <p>5. Downtown Corridor Waste Enclosures Subcommittee approved by Council. Sub-Committee met with Historic Landmarks and 3 main ideas emerged: 1. Use historic photos 2. Use iconic Forest Grove images 3. Do a 'call for art' with a more abstract aesthetic. With 22 garbage cans to cover, identifying appropriate materials to use is a high priority. A contest to request 'kid art' was also proposed. There were varied opinions, but general agreement that whatever was selected for waste enclosures should complement the downtown art installations. Sub-Committee will contact the waste enclosure company for materials recommendations and meet with Councilor Gustafson and the City Manager to review possibilities.</p> <p>6. Annual Retreat Date tentatively scheduled for 9am-12pm, Sat. March 28th, with February 19th PAC meeting also being partially dedicated to planning the 20th Anniversary Celebration.</p>
